The candidates are required to bring **one set of self-attested photocopies of all the documents along with all original documents** for verification as mentioned below :-

- 1. Hard copy of the online application form (While submitting the hard copy of online application form you are requested to **mask** the Mobile No./alternative Mobile No. and Email ID through **blackening**);
- 2. Three recent passport size photographs;
- 3. Duly filled in and attested "Attestation Form" and duly filled in "Bio-data Form" (to be downloaded from the website of the Commission).
- 4. HSC or equivalent certificate in support of declaration of age issued by the concerned Board/Council;
- 5. Post-Graduation certificate/Master's Degree in the subject concerned in respect of educational qualification prescribed;
- 6. B.Ed. certificate;
- 7. Mark-sheets in support of all the Examinations (HSC, Intermediate/+2, Graduation/+3, Post Graduation & B.Ed.) including fail marks, if any, issued by the concerned Board/Council/University;
- 8. Degree or Diploma certificate in Computer Application in respect of educational qualification prescribed;
- 9. Odia Test pass certificate;
- 10. Caste Certificate claim as S.T./S.C./S.E.B.C. wherever applicable;
- 11. Permanent Disability Certificate (including percentage of permanent disability i.e. 40% and more);
- 12. Ex-Servicemen are required to attach copy of Discharge Certificate issued by the Commanding Officer of the Unit last served. They must submit an affidavit undertaking that he/she has not been appointed against any civil post after rectirement from military service, wherever applicable;
- 13. Sports Persons certificate issued by the Director of Sports Odisha;
- 14. Any proof of Identity.

**NOTE** — It is also made clear that the candidature of these candidates for the recruitment is purely provisional. The candidature is liable for rejection in the event of inadequacy/deficiency found at any stage during or after the selection process and is subject to fulfillment of the terms and conditions laid down in the advertisement. Mere participation in the document verification does not reserve any right for selection.
