Indicative Advertisement for Recruitment to the 201 posts of Soil Conservation Extension Worker on contractual basis under Director of Soil Conservation & Watershed Development, Odisha, Bhubaneswar.

- i) Date of activation of the Online Application for the post will be notified in the Detail Advertisement. Candidates are advised to be in constant touch with the above website to apply for the post.
- ii) No Hard copy of the online application is required to be sent to the Commission. The documents as required are to be uploaded while filling up of the application form and self attested copies of all requisite documents/certificates are to be submitted at the time of certificate verification.
- iii) The candidates applying for the post must go through the Detailed Advertisement and ensure that they fulfil all the eligibility criteria prescribed for the post as laid down therein. Admission of a candidate for the written examination & other Tests shall be provisional and would be on the basis of the information furnished by him/her in the Online Application form only.
- iv) If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/her online application is false/incorrect or the candidate has suppressed any relevant information or the candidate otherwise does not satisfy the eligibility criteria prescribed for the post, his/her candidature for the Post/Examination will be cancelled forthwith and he/she may be debarred either temporarily or permanently from appearing any further recruitment examination (s) conducted by Odisha Staff Selection Commission.
- v) As per the Govt. in Agriculture & Farmers Empowerment Department Resolution No. 11804/Ag dated 27.07.2015 and as amended up to date, the upperage limit in respect of existing members of Watershed Management Team/ Watershed Development Team/ Livelihood Support Scheme/ Capacity Building Team and in respect of Technical experts applying for the post of Soil Conservation Extension Worker and fulfils other eligibility criteria, shall be relaxed up to 45 years as on 01.01.2019.

SC-31 (w-11), ST-41 (w-11), SEBC-36 (w-06), UR-93 (w-32).

VACANCIES FOR SPECIAL CATEGORY: PwD-07 (w-02), Ex-Servicemen-07, Sports Person-02.

Candidates of PwD category having minimum 40% disability and Benchmark Disability of Deaf & Hard of Hearing with suitable aid shall be eligible to apply for the post. Candidates having minimum 40% permanent disability are eligible for PwD reservation.

SCALE OF PAY & CONDITION OF SERVICE: The appointment will be initially on contractual basis carrying a consolidated pay of Rs.9, 000/- as per Odisha Group-C & D Posts (Contractual Appointment) Rules, 2013 notified vide G.A. Department Notification No. GAD-SC-Rules-0009-2013-32010/Gen dt. 12.11.2013 and subsequent amendments. The Condition of services shall be governed by Resolution No.11804/Ag dated 27.07.2015 and Amendment No.12541/Ag dated 07.08.2015 of Govt. in Agriculture & Farmers Empowerment Department, Odisha, Bhubaneswar. .

ELIGIBILITY:

i) Age:

Must not be below 21 years and above 32 years of age as on 01.01.2019. The upper age limit is relaxable by 5 years in case of SEBC,SC,ST & Women candidates, 10 years relaxation in case of PwD category candidates, the period of service rendered in Defence Forces in case of Ex-SM Candidates and upto 45 years as on 01.01.2019 in case of In-Service Contractual Employees subject to condition that he/she has completed one year of continuous service prior to commencement of the above Rule.

PwD candidates in the ST & SC category shall be entitled to avail cumulative age relaxation of ten years over & above the normal relaxation specified for the category.

ii) Educational Qualification: The Candidate must have passed +2 Science or +2 Vocational courses in Agriculture related subject i.e. Crop
Production (CP)/ Horticulture/ Repair & Maintenance of Power Driven Farm Machinery (PDFM) from any recognized
Board/ Council or Institution.

The applicant must have Odia as one of the subjects in the HSC or passed examination in Odia equivalent to M.E. standard or passed in Odia as language subject in final examination of Class-VII or passed a test in Odia in M.E. School Standard conducted by Education Department Govt. of Odisha on the date of the Application.

- iv) PLAN OF EXAMINATION:
- i) Main Written Examination -220 marks (Paper-I GS&LA 100 marks- 1^{1/2} hour and Paper-II Technical Paper 120 marks 1^{1/2} hour)
- ii) Certificate verification
- (a) Certificate Verification: Candidates two times of the vacancies in order of merit category wise basing on the sum total of marks secured in Paper-I and Paper-II of Written Examination shall be shortlisted for verification of original certificates.
- (b) Merit List: The merit List of the candidates found suitable in Certificate Verification shall be prepared basing on the marks secured in Written Examination. Select list equal to the vacancies notified shall be prepared from the merit list.

EXAMINATION FEE: Candidates in order to apply for the post must deposit a non-refundable Fee of Rs.200/- (Rupees two hundred only) through online mode using banking channel/payment gateways (refer to the detailed advertisement).

The ST, SC & PwD candidates are exempted from paying any examination fee.
