Post - PGT (Economics)-Male in DoE & PGT (Economics) in NDMC under Combined Examination Post Code- 809/23

- 1. The DSSSB vide its vacancy notice/Advertisement No. 07/23 dated 22/12/2023 with closing date 07/02/2024 & Corrigendum no. 5070-81 dated 19/02/2024 had advertised 28 vacancies [(UR-16, OBC-04, SC-01, ST-03, EWS-04 including PwBD {Cat(a)-01, Cat(b)-01, Cat(c)-01 & Cat(d&e)-01}] for the post of PGT (Economics)-Male in Directorate of Education & PGT (Economics) in NDMC under the Combined Examination Post Code 809/23.
- 2. The online written examination One Tier (Technical/Teaching) for recruitment in respect of this post was conducted on 21/07/2024.
- 3. The prorated marks obtained by 1851 candidates who appeared in Tier-I written examination were uploaded on DSSSB website vide notice no. 1554 dated 06/08/2025. Out of 1851, only 110 qualified candidates were shortlisted to upload documents in e-dossier module and exercise at least one preference in OARS from 08/08/2025 to 22/08/2025 subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form.
- 4. As per the provisions of the Notice no.1554 dated 06/08/2025, allocation of posts/Departments to eligible candidates has been made on the basis of Merit-cum-Preference of posts submitted by the candidates during filling e-dossier in the OARS module. Once a post/department is allocated, no change of posts will either be entertained or allowed by the Board.
- 5. As per the Board's resolution dated 14/07/2022, no scrutiny of documents uploaded in the e-dossiers and of the other terms and conditions of recruitment notified by the Board in the advertisement of the said post code has been done by the Board. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement no. 07/23 and relaxations as per rules in respect of educational qualifications, experience, other certificates shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 809/23 as on cutoff date 07/02/2024 before issuance of offer of appointment to the post.

- 7. The provisionally nomination of the above 22 candidates [UR-10, OBC-02, SC-01, ST-02, EWS-04, PwBD {Cat(a)-01, Cat(c)-01 & Cat(d&e)-01}] for the post of PGT (Economics)-Male in Directorate of Education and 05 candidates [UR-02, OBC-02, ST-01] for the post of PGT (Economics) in NDMC shall be further subject to thorough verification of candidature of the candidate by the User Department including the identity of the candidate.
- 8. The provisionally nomination of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs,

signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the User Department in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

- 9. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally nominated candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 10. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 11. The User Department shall also get the SC/ST/OBC/EWS/PH certificates verified from the issuing authority before his /her appointment.
- 12. In case of EWS candidates, it may also be verified that the validity of EWS Certificate should be as per DoPT OM No. 36039/1/2019-ESTT(Res) dated 31/01/2019 and other instructions/guidelines issued from time to time by the competent authorities.
- 13. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about their eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 14. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 15. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable

in all respect for appointment to the Post.

- 16. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 17. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
