- 2 As per Notification Diploma in Pharmacy/ Bachelor of Pharmacy qualification considered.
- 3 The Applicants applied under EWS reservation should submit Latest EWS certificate issued by the concerned Tahsildars in Andhra Pradesh for the F.Y. 2025-26. If fails to submit the required certificates at the time of certificate verification, those are not considered for selection under EWS category.
- 4 The candidates have to submit the valid A.P.Pharmacy Council Registration Certificate along with latest renewal in original at the time of certificate verification. Failing which, their selection will not considered and treated as disqualified.
- 5 The selection was made subject to the availability of vacancies as per merit-cum-Rule of Reservation only.
- 6 The candidates who have submitted for weightage for contractual service marks they should submit their bank account statements for verification purpose for their rendered service as per service certificate issued by the concerned officers prior to counselling.
- 7 The Contractual service certificates submitted by the selected candidates will be addressed to the officers concerned for genuinity. If any certificate found as fake or fabricated the candidates who submitted such certificates will be terminated from service besides filing a criminal case will be filed against the individual concerned.
- 8 The Original certificates of selected candidates will be verified at the time of counselling. During the course of verification, if any defects are found, the selection of the candidate will be withheld and their rank will be re-assigned according to the original merit.
- 9 The Candidates have not any right for appointment even though their names in the final merit list as the selection process is purely made according to Merit-cum-Rule of Reservation.
- 10 The No.of Vacancies notified is tentative and may increase or decrease.
- 11 The counseling date will be communicated shortly to the candidates.

8. If any tampering of marks or any other information noticed at the time of verification, criminal proceedings besides disqualifying in the present selection and debarment for further notifications.
9. The academic, technical and service certificates will be referred to the authorities concerned. If any certificates found fake/ fabricated, they will be terminated from service besides initiating criminal proceedings.
10. If any candidate found selected and posted to the places in Zone II as per Notification No.01/2024 during the course of Original Certificates verification and counselling, their selection will be with-held and deleted from the selection list.
